Change in Public Access Hours at the Courthouse By Debbie Spradley

On **Monday, February 3, 2020**, the Clackamas County Circuit Court expanded its public service hours in most of the operation areas at the courthouse. The main change you will see in the chart below is the addition of public service hours from 12-1pm.

As background, we changed our public service hours in 2009 in response to budget reductions, that included mandatory staff furloughs (both court closure days and floating days off) and permanent loss of staff positions. Since that time, we have gone through further budget reductions, but we have also implemented a new case management system (Odyssey) in December 2015 that included going to a paper on demand and eFiling system. As we have come up to speed on the new case management system, we have found ways to build in efficiencies. This change was also made possible thanks to restored funding from the legislature and efforts by the Chief Justice and state courts leadership to prioritize public access to justice. I know that the Clackamas County Bar Association also supported this effort and we want to thank you for that!

We believe that making this change will improve access to justice at our court, and we are committed to finding ways to make this work. Our long-term goal is to increase the public access hours further, so you should expect to hear about more changes in the months ahead.

Member Profile: Christine Landers by Wendy Van Leuven

This year, the CCBA Board has agreed to focus on attorneys that are special to us Board members, attorneys that we admire...and dare say fan over? So for this edition, I begged to write about Christine Landers, Clackamas County Senior Deputy District Attorney.

Christine graduated from high school in Idaho. After being awarded the honor of National Merit Scholar, she decided to attend the University of Utah. Of course, she graduated with high honors, since nothing Christine does is halfway or ordinary. She moved to the Pacific Northwest to attend Lewis and Clark Law School. She secured a summer clerkship with Schwabe, Williamson & Wyatt, a local firm in downtown Portland. The folks at Schwabe were no fools and, at the end of the summer leading into her third year of law school, they offered her an associates position upon graduation. As an associate with Schwabe, she participated in the "DA Day For A Day" program through Multnomah County District Attorney's Office. This was a 10-week program that allowed civil attorneys to obtain trial experience by handling the prosecution of misdemeanor cases such as prostitution, driving under the influence and criminal trespass cases. For Christine, this opportunity made her realize that trial work was what interested her the most and that work as a prosecutor was were where she wanted to take her career.

In 1996 she applied and accepted a position with the Clackamas County District Attorney and she has never looked back.

Over the years, she has earned a reputation as one of the most respected and best trial attorneys in the Clackamas County District Attorney's office. Deputy District Attorney, Sarah Dumont, explained, "Christine has dedicated her practice to helping children, especially the victims of sexual abuse." When I asked Sarah what it is like working with Christine she quickly said, "She cannot only argue complex legal ideas on the fly but she can distill them into relatable analogies to devastating effect."

Senior District Attorney, John Wentworth, hit the nail on the head as to why she is so respected, "Christine has a mind like a steel trap. She can recall names and facts of cases years later with little difficulty. And, her mind never stops moving as evidenced by her sense of humor. She can take the most mundane of comments and point out the absurdity of it in an instant." Sarah Dumont added, "I have seen Christine write a

well-reasoned and persuasive motion over lunch and then successfully argue it that same afternoon."


For Judge Colleen Gilmartin, one of her favorite aspects of working with Christine, when she was in the District Attorney Office, was Christine's sense of humor and drive. She also quipped about how Christine would often start a conversation with, "have you read...". It is no surprise to anyone who knows Christine that she is an avid reader. Avid minimizes Christine's reading. Voracious is more appropriate. Last year alone she read 190 books.

When asking her to name her favorite books and authors Christine rattled off the following, Edith Wharton, Willa Cather, Agatha Christie, Louise Penny and Michael Connelly. As a child, her favorite book was The *Lion, The Witch and The Wardrobe* by C.S. Lewis. In college, she appreciated Armistead Maupin's *Tales of the City* because it opened her eyes and allowed her to see the world was bigger than she knew. Years later, as an adult Laurie Colwin's *A Big Storm Knocked It Over*, a novel about marriage and a new baby - life on the small scale - really resonated with Christine.

In regards to a life on a small scale, Christine downplays all her accomplishments. She conquers books, she quilts, she owns the courtroom and Christine is also the mother of two amazing adults, with her husband of 25 years, David. It is no surprise Christine is humble about her marriage and her children. She attests these not so small accomplishments and successes are really only attributable to David, but those who know her, know she was and is a solid steadfast strength to these successes

In short, Sarah Dumont sums up what makes Christine so special, "she is...irreverent and well-read. In short, the type of person you want to have on your legal team and as a friend."


